#### - DECLARATION -

SubDomain (web) Usage Principles

- 1. The internet usage policies of Ulaknet apply to the subdomain web content you have requested from the Directorate of Information Technologies. Please refer to the following address for more information: (http://www.ulakbim.gov.tr/ulaknet/kullanim-politikasi.uhtml).
- 2. At Abdullah Gül University;
- In accordance with the received requests, appropriate web quotas are provided for academic units for unit pages or for symposiums and similar events. Web subdomains created for events will be closed after the event ends, based on notification from the unit. The given usernames and passwords will be deleted from the system. These quotas can be increased based on the request and need of the individual. An application form is required for these areas.
- 3. The user accepts that the right to use the service is solely theirs, will not share their private and confidential password and username/code with anyone, and will immediately change them if suspected of being known by others. Otherwise, the user will be responsible for all actions taken and cannot claim non-usage.
- 4. The user accepts that all ideas, thoughts, expressions, and writings expressed in the system are their own and that the Directorate of Information Technologies is not responsible for them in any way.
- 5. The user cannot engage in any activities such as sending bulk promotional materials, mailings, or other activities with the intent to insult, spread pornography, or other illegal or morally unacceptable content in Internet newsgroups, chat environments, or emails associated with the subdomain and the web page publishing rights granted to them.
- 6. The user cannot host pornographic images, animations, videos, etc., or provide links to such sites on their account and/or site. University-owned network and server computers cannot be used to produce and distribute inappropriate, obscene, and disturbing images (except for academic and scientific research purposes).
- 7. The user cannot include materials and documents that constitute a legal crime in their account and/or site. They cannot use applications that harm public and commercial services or personal account holders.
- 8. The user cannot host or publish Hack/Crack-based documents except for educational purposes in their account and/or site. They cannot use another system's mail server or another user's mail account to send messages without explicit permission.
- 9. The user cannot publish defamatory and similar publications about public institutions or organizations, real/legal persons, or encourage such actions on their account and/or site. They cannot produce and distribute defamatory, false, distressing, disturbing, or unnecessarily frightening material.
- 10. The user cannot publish exposed passwords in their account. They cannot host documents containing information on breaking passwords and similar protection methods except for educational and protective purposes. They cannot engage in activities such as unauthorized use of computer and communication resources, destroying others' data, accessing personal information, disrupting or destroying others' work.
- 11. The user cannot include commercial advertisements and foreign/local sponsored advertisements obtained through membership, links, etc., in their account and/or site. They cannot publish unwanted messages such as commercial advertisements and news announcements.
- 12. All legal responsibilities arising from the publication rights of documents and any information in the account and/or site belong entirely to the user. The user cannot distribute materials that infringe others' intellectual property rights according to the law on intellectual and artistic works (copyright).
- 13. The user's subdomain web account can be temporarily closed by the Directorate of Information Technologies without notice in the following cases:
  - Illegal use as determined by the laws of the Republic of Turkey,
  - Non-compliance with the usage policies determined by ULAKNET,
  - Exceeding the limits set for user accounts,

- Determination that personal user accounts are being used by different people,
- Attempting to find other users' passwords, interfere with their files, modify them, etc., on the server systems,
- Interference with the accuracy, integrity, security, and service continuity of the system. Users will be informed in advance if their accounts are to be permanently closed.
- 14. Violating the security of the systems and networks belonging to Abdullah Gül University, engaging in activities that affect, disrupt, or create confusion in the quality of service is prohibited and may result in legal and criminal responsibility. The Directorate of Information Technologies investigates such violations and cooperates with law enforcement if a crime is suspected.
- 15. The Directorate of Information Technologies cannot be held responsible for any information lost and/or incomplete during Internet traffic, or for the complete accuracy, validity, or timeliness of the information published on the Internet platform or their publications.
- 16. The user is responsible for all restrictions and sanctions within legal rules, personal rights, and actions within moral rules, and all universal rules within Internet ethics, even if not listed item by item. If the user does not comply with the mentioned rules, their account may be temporarily frozen, and in case of continuation or repetition, they will be indefinitely removed from membership and their account will be canceled.
- 17. It is prohibited to publish or host any information that includes any illegal, threatening, disturbing, insulting, obscene, defamatory, demeaning, vulgar, pornographic, disturbing, or immoral information on corporate pages, which creates or encourages a situation that constitutes a crime, requires legal action, is contrary to the laws nationwide or internationally, or in any form or manner of transmission..
- 18. The user accepts and undertakes to comply with the articles in this contract from the moment they start benefiting from the services mentioned above. The subdomain user is responsible for all legal and administrative actions if they do not comply with the stated rules. The Directorate of Information Technologies reserves the right to change this subdomain usage policy, considering possible legal, administrative, and technological developments. The amended contract will be effective as soon as it is posted on the website of the Directorate of Information Technologies.

We agree to comply with the above conditions while using Abdullah Gül University's subdomain web system. Therefore, the Directorate of Information Technologies is not responsible for any direct or indirect damages that may arise from the resulting consequences.
